ADMISSION for classes from LKG to VIII: 2019-2020

- Date schedule for the Interview of **LKG** students will be on the notice board on by **5th February**.
- Photostat copies of the following documents have to be submitted along with the application form.
 - * **Birth certificate of the child.**
 - * **Aadhar Card**
 - * **Residence Proof** :- (1) Recently paid BSNL/MTNL Telephone Bill (Mobile phone bills will not be accepted) (2) Electricity Bill (3) Receipt of House Tax Bill (4) Passport. [Any one of these should be in the name of the father of the child.] If no such documents are available, kindly produce an affidavit.
- Affix a recent passport size photograph of the child in the space provided on the application form.
- All entries should be legible; incomplete and illegible forms will be rejected.
- The application forms should be submitted at St Francis de Sales School Rohtak Road Jhajjar within two days after obtaining the Registration forms.
- For books, school diary, admit card and uniform and stationary items will be separately called on another day. The Dates will be intimated on the day of Admission.
- The Management reserves the right for admission. It is not obliged to offer any reason or explanation for its decision.
- **The amount paid for the prospectus and registration form is not refundable.**
- For **LKG** admission Interaction will begin from 5th Feb. Both the Parents should be present along with the child.
- School transport facilities will be available only on the Routes displayed on the notice board.
